## PLEASE JOIN THE VICTORIAN HIRE CAR ASSOCIATION (VHCA) FIGHTING FUND

On August 23<sup>rd</sup> 2016 Premier Andrews along with Minister for Public Transport, Ms Jacinta Allan, announced a series of changes that will seriously affect Hire Car operator and driver's viability and ability to compete against ride share. These changes can damage your business and could seriously impact your capability to service your debts and create an income for you and your families. The Andrew's Government will compulsory acquire assets (hire car licence's) that you own.

***\$25,000 for your first licence, \$12,500 second licence and nothing for subsequent licences***

The VHCA believe that these changes are not fair and may need to be tested in Court. So we will need to raise monies to fund our fight, and so we propose the following,

We request that each MH licence holder contributes \$500 per licence - \$250 now and \$250 at a later stage

We request that each Special Vehicle licence holder contributes \$100 per licence.
